- ◆ **1689** : The British Parliament guaranteed religious freedom to **Protestant Christians**.
- ◆ **1954** : **Bachendri Pal**, the first Indian woman to climb **Mount Everest**, was born.
- ◆ **1875** : **Syed Ahmed Khan** founded the **Muhammadin Anglo-Oriental School** in **Aligarh**, which is now known as **Aligarh Muslim University**.
- ◆ **1952** : Former Indian **Foreign Secretary** of India **Ranjan Manthai** was born in

Current Affairs Related to 24th May

- ◆ **The Kerala government will launch** a state-owned over-the-top platform on **November 1**, which will offer film lovers a range of films, short films and documentaries of their choice. Kerala will become the first state in India to have a state-owned over-the-top (OTT) platform. Kerala's Minister for Cultural Affairs **Saji Cheriaan** named the OTT platform as **CSPACE**. CSPACE is an initiative of the Kerala State Film Development Corporation on behalf of the State Government.
- ◆ **Chinese scientists have proposed** a space project to survey the sky through a space-borne telescope to hunt for habitable-like planets outside the Solar System, some **32 light years** from Earth. The project, named the **Closeby Habitable Exoplanet Survey**, will be the first space mission specifically designed to search for habitable terrestrial planets around Sun-like stars.
- ◆ **PNB MetLife India Insurance Company** has launched India's first dental health insurance plan. It is the first insurance plan in India that covers fixed benefit outpatient expenses and provides financial assistance along with costs related to overall dental health. This launch strengthens PNB MetLife leadership in this industry with this one-of-a-kind standalone, dental health insurance plan that covers major dental procedures without the hassle of hospitalisation.
- ◆ **RBL Bank, Amazon Pay and Amazon Web Services have partnered together** to deliver a universal payment interface payment, which will include peer-to-peer and peer-to-merchant transactions. Amazon Pay will provide @rapl Bank with a UPI ID with the handle of National Payments Corporation of India, resulting in a seamless payment experience using RBL Bank's cloud-based processing infrastructure.
- ◆ **Adani Sportsline, a division of the diversified Adani Group, has created history** by acquiring the rights to own and manage a franchise in the UAE's top T20 competition. The UAE T20 League, licensed by the Emirates Cricket Board, is an annual event involving six franchise teams participating in a 34-match tournament. The line-up of various teams is likely to include top players from all the cricket playing nations. The league will provide a platform and exposure to the young cricketers of the future.
- ◆ **Nikhat Zareen stunned Thai Olympian Jutamas Jitpong by 5-0 to become** the fifth Indian woman to win a world title at the Women's World Championships, Istanbul. Nikhat thus became only the fifth Indian female boxer after Mary Kom, Sarita Devi, Jenny RL and Lekha KC to win gold at the World Championships.
- ◆ **The wax museum Madame Tussauds is returning to India. The museum will be located** in the Noida Mall. The new venue will be attended by 50 Indian and international stalwarts from sports, entertainment, history and music. Madame Tussauds India will let visitors stand up and get personal with celebrities as well as some of their most iconic moments. Madame Tussauds has 200 years of history and heritage, having first opened its doors in London in 1835.
- ◆ **The Reserve Bank of India has said that public sector banks have reported** a 51 per cent decline in the amount involved in frauds to Rs 40,295.25 crore during the financial year 2021-22. The central bank, in response to an application under the Right to Information Act, said that in the last financial year 2020-21, 12 PSBs had reported frauds amounting to Rs 81,921.54 crore.
- ◆ **The Supreme Court has constituted a three-member committee** of administrators headed by AR Dave to manage the affairs of the All India Football Federation.

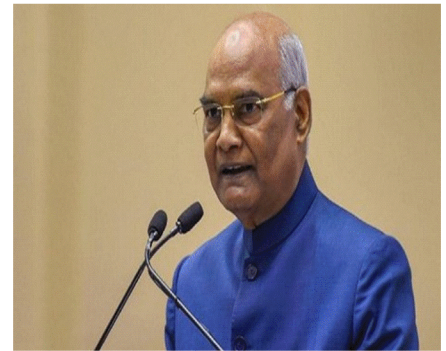
