History of November 3

- ◆ **1948** : Jawaharlal Nehru, the then Prime Minister of India, gave his first speech at the United Nations General Assembly.
- ◆ **1984** : More than three thousand people were killed in the anti-Sikh riots in India.
- ◆ **1962** : Gold bond scheme was announced in India in the wake of China's attack.
- ◆ **2000** : Direct to home broadcasting service was started for all by the Government of India.

Current Affairs Related to 3 November

- ◆ **Indian Air Force and French Air and Space Force** are participating in the bilateral exercise from 26 October to 12 November 2022. The exercise is being conducted at Air Force Station Jodhpur. It is named as Garuda Tappa. The joint exercise provides a platform for both the countries to enhance operational efficiencies and interoperability and share best practices. This is the seventh edition of the bilateral exercise. Details about other versions are given in the next table.
- ◆ **Dabur India, which is the country's oldest FMCG company that makes products used for daily needs,** is soon ready to knock in the spice market. For this, Dabur Company has acquired the ownership of the company by buying 51 percent stake in Badshah Masala. For which both the companies have issued a joint statement.
- ◆ **Producer director SS Rajamouli's RRR is the most talked about film of this year.** This film is being liked not only in India but all over the world. The film has also been applied for next year's Oscar Awards 2023. Before going to the Oscars, SS Rajamouli's film RRR has achieved special success abroad.
- ◆ **Reliance Industries Limited posted the proceedings of its Q2 FY 2022.23 Earnings Call on Metaverse.** This is the first time in the history of Corporate India that a company has used Metaverse to connect with its stakeholders. Reliance Industries Limited Metaverse was created in partnership with Gmetri, a no-code metaverse creation platform. There is no need to access it.
- ◆ **The number of people who were forcibly displaced from their homes due to incidents** of persecution, conflict, violence, human rights violations and disturbing public order globally increased to 103 million in the first half of 2022, which means That one in 77 people on Earth has been forcibly displaced.
- ◆ **Indian Foreign Service officer Dr Rajesh Ranjan has been appointed as the next Indian Ambassador** to the West African country of Cte d'Ivoire or Ivory Coast. Dr. Rajesh Ranjan is currently posted as High Commissioner of India to the Republic of Botswana. Dr. Ranjan has a PhD in Economics from Allahabad University. Dr Rajesh Ranjan was Director in the Americas Division in the Ministry of External Affairs and handled issues relating to India's relations with the US and Canada.
- ◆ **Indian scientists have developed an Overhauser magnetometer, which is one of the best such magnetometers** widely used by all magnetic observatories across the world, to reduce the cost of sampling and sensing experiments required for geomagnetic sampling. paves the way for The sensor installed at the Alibaug Magnetic Observatory could solve India's reliance on commercial OVH magnetometers for geomagnetic field measurement.
- ◆ **The Reserve Bank has canceled the certificate of authorization of Chennai-based GI Technology Pvt Ltd** over governance concerns in the company. The company is in the business of issuing and operating prepaid payment instruments. Governance concerns and non-compliance with regulatory requirements are the reasons for the revocation of the authorization certificate, the central bank said in a statement.
- ◆ **ICAR successfully tested two new varieties of Kalanamak rice.** Kalanamak is a variety of rice, which has black husks and a powerful aroma. Indian Agricultural Research Institute tested two new varieties named Pusa Narendra Kalanam 1638 and Pusa Kendra Kalanam 1652 in Uttar Pradesh. These varieties give double yield. They are rich in micronutrients like iron and zinc and help prevent Alzheimer's. It is grown in 11 districts of the Terai region of northeastern Uttar Pradesh and Nepal.
